Refinancing Your Student Loan Debt

There is a lot of talk in the media about refinancing student loan debt. In case you've missed it, Senator Elizabeth Warren from Massachusetts proposed legislation to allow students to lower their interest rates through refinancing. Our homes can be refinanced, so why not student loans? (Note: As of 6/11/14, this bill has been blocked by the Senate—please stay tuned for more updates.)

What should a student consider if this option becomes available?

- Are you actually receiving a lower interest rate or are you extending the loan to get a lower payment? There's a big difference.
- Is the rate fixed or variable? Fixed rate loans will have payments that do not change for the life of the loan.
- Will you be mixing federal student loans with private student loans when refinancing? If so, your lender should inform you of any lost benefits such as Public Service Loan Forgiveness.
